This event will take place giving emphasis on our social and political crisis of values and structures with emphasis on social policies in the crisis in order to maintain social cohesion and dignity of our fellow human beings and to give the perspective of revival to the Greek society.



Kevin Featherstone is Eleftherios Venizelos Professor of Contemporary Greek Studies and Professor of European Politics. He is the long-term Director of the Hellenic Observatory and Co-Chair of LSEE: Research on South-East Europe within the European Institute. Between 2004 and 2007, and then 2012-13, he also served as Director/Head of the European Institute. He has held visiting positions at the University of Minnesota; New York University; and Harvard University.



George Kaminis is Mayor of the City of Athens. After serving as a Deputy Ombudsman for Human Rights, from 1998 to 2003, he served as the Greek ombudsman from April 2003 until his resignation in September 2010, to run on the oncoming local elections.



Manos Matsaganis is Associate Professor of European Social and Employment Policies at the Athens University of Economics and Business. He has previously worked at the London School of Economics (Welfare State Programme, 1990-1993), and at the Greek Prime Minister's Office (Strategic Planning Division, 1997-2001). He is a member of the High-Level Expert Group on Social Investment for Growth and Cohesion (European Commission – DG Employment, Social Affairs and Inclusion).



Elias Mossialos is Brian Abel-Smith Professor of Health Policy at the Department of Social Policy at LSE, and Director of LSE Health. His particular focus is European and comparative health systems and policy, addressing questions related to funding health care, private health insurance, pharmaceutical policies, the impact of EU law on health care systems, and access to medicines in developing countries.

– One of the founders of the citizens' movement Dynamic Greece.



Chair: Nikitas Konstantinidis is Dr Nikitas Konstantinidis is a Fellow in Political Science and Public Policy in the Department of Government at LSE. He received his PhD in Political Economy from the Woodrow Wilson School, Princeton University, and has further pursued postgraduate studies at the Kennedy School of Government, Harvard University, and undergraduate studies at LSE.

The event on Economic crisis will be focusing on the future of the Greek economy from now on, and in particular what are the economic policies that should immediately be followed both at National and European Level in order to sanitize the economy of Greece and at the same time put it in an orbit of growth.



Nicos Christodoulakis is Professor of Economic Analysis at the Athens University of Economics and Business, Department of International and European Economics. Research Associate, Hellenic Observatory, LSE.

– Analysis of Greece and the Eurozone, with emphasis on debt sustainability, fiscal policy, privatisations, growth and external balances.

– 1996-2000: Deputy Minister of Finance.

– 2001-04: Minister of the Economy and Finance, Greece. During the Greek EU presidency, chair of the Euro group and Ecofin. Final negotiation of the Taxation on Savings Directive. Participation in several G7 meetings.



Paschos Mandravelis holds a daily column on politics, society and economics in the daily newspaper *Kathimerini*. He authored five books, and co-authored many more. The last book he co-authored is *On violence. The ideological component* (2012, Polis Publications). He studied Economics and Media.



Elias Papaioannou is Associate Professor of Economics at the London Business School. He is also a research affiliate of the CEPR (Centre for Economic Policy Research) and the NBER (National Bureau of Economic Research), the leading research institutes in Europe and the United States, respectively. During the 2010-11 and 2011-12 academic years he was a Visiting Assistant Professor at the Economics Department of Harvard University (MA, USA).



Dimitri Vayanos is Professor of Finance at LSE and Director of the Paul Woolley Centre for the Study of Capital Market Dysfunctionalities. Prior to joining LSE, he was faculty member at Stanford and MIT. His research, published in leading economics and finance journals, such as the *Journal of Finance*, the *Journal of Financial Economics*, the *Quarterly Journal of Economics*, the *Review of Economic Studies*, and the *Review of Financial Studies*, focuses on financial markets with frictions, and on the frictions' implications for market liquidity, market anomalies and limits of arbitrage, financial crises, welfare and policy.



Chair: Stavros Panageas, LSE Visiting Professor in Finance, Associate Professor of Finance in The University of Chicago Booth School of Business. He joined the Chicago Booth faculty in 2008. Previously he has taught at the Wharton School of the University of Pennsylvania. He is a Faculty Research Fellow of the National Bureau of Economic Research and he has been a visiting scholar at the Federal Reserve Bank of Minneapolis and LSE.
